<p><b>Removal goods – Foreign EU Citizens</b></p>	<ul style="list-style-type: none"> <li>▪ Clear passport copy.</li> <li>▪ Clear copy of Slovak residence permit card.</li> <li>▪ Copy of rental contract.</li> <li>▪ Original of Power of Attorney, filled and signed by shipper (not printed scans!)</li> <li>▪ Original, filled and signed declarations.</li> <li>▪ Original confirmation from employer in Slovakia - confirming work position, length of stay in Slovakia (must be original document, signed and stamped).</li> <li>▪ Inventory/ packing list with serial numbers of all electric items – mandatory.</li> <li>▪ Confirmation that the shipper has spent the last 12 months abroad (rental contract, confirmation from employer abroad).</li> <li>▪ Confirmation that the shipper ended his/her stay in the country from where shipment is coming (example: end of residence permit card, end of visas, end of rental contract, end of medical insurance – the more the better).</li> <li>▪ Value of the shipment.</li> <li>▪ Exact delivery address / access information.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Household goods and personal effects may be imported duty and tax free if the following conditions are met:                             <ul style="list-style-type: none"> <li>▪ The goods must have been used for a minimum of 6 months.</li> <li>▪ The goods may not be sold and may only be used for shipper’s own purposes during the period stated by the Customs office.</li> <li>▪ The shipper must have lived abroad for more than 12 months before prior to entry into Slovakia.</li> <li>▪ Household goods and personal effects must be imported within 6 months after shipper’s arrival date.</li> </ul> </li> <li>▪ Alcohol:                             <ul style="list-style-type: none"> <li>▪ Not exceeding 22% volume: 1 litre</li> <li>▪ Exceeding 22% volume or denatured ethyl alcohol 80% volume and higher: 1 litre</li> <li>▪ Beer: 14 litres</li> <li>▪ Wine: 3 litres</li> <li>▪ From all alcohols are being paid duties and taxes in amount of 30-40 % +20% VAT of the value + volume, % of alcohol, name of the alcohol.</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ No food into the shipment.</li> </ul>

<b>Removal goods – Returning Slovak Citizens</b>	<ul style="list-style-type: none"> <li>▪ Clear passport copy.</li> <li>▪ Clear copy of Slovak ID card “Občiansky preukaz”.</li> <li>▪ Original of Power of Attorney, filled and signed by shipper, must be confirmed by Slovak Notary office.</li> <li>▪ Original, filled and signed declarations.</li> <li>▪ Confirmation that the shipper has spent the last 12 months abroad (rental contract, confirmation from employer abroad).</li> <li>▪ Inventory/ packing list with serial numbers of all electric items – mandatory.</li> <li>▪ Confirmation that the shipper has spent the last 12 months in country from which is coming to Slovakia (rental contract, confirmation from employer abroad).</li> <li>▪ Confirmation that the shipper ended his/her stay in the country from where shipment is coming (example: end of residence permit card, end of visas, end of rental contract, end of medical insurance).</li> <li>▪ Value of the shipment.</li> <li>▪ Exact delivery address / access information.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Same as above.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Same as above.</li> </ul>

<b>Diplomat Removal – Foreign Diplomat</b>	<ul style="list-style-type: none"> <li>▪ Clear copy of diplomatic passport.</li> <li>▪ Clear copy of diplomatic ID card (issued by Ministry of Foreign Affairs in Slovakia).</li> <li>▪ Bordereau in original</li> <li>▪ Original of Power of Attorney, filled and signed by shipper, confirmed by relevant department - Ministry of Foreign Affairs, Embassy.</li> <li>▪ Original, filled and signed declarations.</li> <li>▪ Original confirmation from employer (Embassy, Ministry, Consulate, confirming stay in Slovakia – must be original document, stamped).</li> <li>▪ Inventory/ packing list with serial numbers of all electric items – mandatory.</li> <li>▪ Value of the shipment.</li> <li>▪ Exact delivery address/ access information.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Alcohol: <ul style="list-style-type: none"> <li>▪ Not exceeding 22% volume: 1 litre</li> <li>▪ Exceeding 22% volume or denatured ethyl alcohol 80% volume and higher: 1 litre</li> <li>▪ Beer: 14 litres</li> <li>▪ Wine: 3 litres</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>▪ No food in the shipment.</li> </ul>
<b>Diplomat Removal – Slovak Returning Diplomat</b>	<ul style="list-style-type: none"> <li>▪ Clear copy of diplomatic passport.</li> <li>▪ Clear copy of diplomatic ID card.</li> <li>▪ Bordereau (original) if issued</li> <li>▪ Confirmation from Ministry of Foreign Affairs for his mission abroad (original required).</li> <li>▪ Original filled and signed declarations.</li> <li>▪ Original of Power of Attorney, filled and signed by shipper, confirmed by relevant department – embassy/Ministry of Foreign Affairs.</li> <li>▪ Inventory with serial numbers of all electric items – mandatory.</li> <li>▪ Value of the shipment.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Same as above.</li> </ul>	<ul style="list-style-type: none"> <li>▪ Same as above.</li> </ul>

<p><b>Dangerous items</b></p>		<ul style="list-style-type: none"> <li>▪ Explosives (grenades, ammunition, fireworks, toy caps).</li> <li>▪ Flammable goods (matches, firelighters, certain batteries, soldering iron).</li> <li>▪ Radioactive materials (radioactive medicine).</li> <li>▪ Flammable gas (gas cylinders, lighter fuel, aerosols).</li> <li>▪ Oxidising substances (bleach, chlorine, peroxide).</li> <li>▪ Corrosives instruments containing mercury, acids (thermometer, laptop battery).</li> <li>▪ Flammable liquids (paints, fuel, thinners).</li> <li>▪ Poison (poisons, pesticides).</li> <li>▪ Miscellaneous dangerous goods (dry ice, magnetic objects, diving lamps, ink cartridges).</li> </ul>	
<p><b>Motor vehicles</b></p>	<ul style="list-style-type: none"> <li>▪ License/Certificates and Titles of the car.</li> <li>▪ Value of the car / Purchase invoice of the car.</li> <li>▪ All mentioned documents above as per nationality of client.</li> </ul>	<ul style="list-style-type: none"> <li>▪ To be imported taxes/duties free, car must be older than 6 months.</li> <li>▪ All available information about the car requested: engine, kWh, fuel, tires mark, number of tires, etc..</li> </ul>
